EU Customs ICS2 Cargo Declaration User Guide (1.0)

The European Union (EU) Customs has announced to implement new regulations for manifest declaration. If the goods are transported to or through the EU (including FROB goods), carriers must submit ENS through European Union's Import Control System 2 (ICS2). Based on Customs declaration requirements and our company's operational procedures, please provide relevant information according to the following guidelines.


1 New data elements

The new regulations require you to provide new data elements based on ENS submission which are listed below.


- 1.1 At least 6 digits HS (Harmonized System) Code with complete and detailed cargo description.
- 1.2 EORI (Economic Operator Registration and Identification) No.:
 An EORI No. is assigned when you register your company as an importer or exporter in the EU Customs. The EORI No. is mandatory for ENS filing.
- 1.3 Full address of Consignee, including Country Name, City name, Street name + number or PO Box number.

2 Direct customer filling in declaration information

- 2.1 Direct customers are required to declare the information of buyer and seller directly to the EU Customs (self-filing).
- 2.2 Complete the following information through the official website of COSCO Shipping Lines.
 - 2.2.1 Login to the <u>COSCO SHIPPING Lines</u> Website. Select 'Documents' on the left side menu, and proceed to complete the essential manifest details within 'Details' and 'Containers and Goods' section.



- 2.2.2 Filling in the EORI No.
 - Fill in the EORI No. in the 'R24 Customs Filing Information'— 'EU' field under 'Container and Cargo' section.




• **Do not tick the checkbox** for 'House Master Shipment'. Please proceed to choose 'Self-Seller' in the 'Buyer & Seller information filing' field, and fill in the EORI No. in the textbox of 'Declaration EORI (Buyer & Seller Declarant)'.




2.2.3 Filling the cargo description

Fill in the detailed and accurate cargo name in the 'Summary Cargo Description' field, and input an HS Code with at least six digits in the 'HS Code' field.




3 Freight Forwarders and NVOCC filling in declaration information

- 3.1 Forwarder and NVOCC are required to declare the house bill of lading directly to the EU (self-filing).
- 3.2 Complete the information through the official website of COSCO Shipping Lines
 - 3.2.1 Login to the <u>COSCO SHIPPING Lines</u> website. Select 'Documents' on the left side menu, and proceed to complete the essential manifest details within the 'Details' and 'Containers and Cargo' sections.



3.2.2 Filling in the EORI No.

• Fill in the EORI No. in the 'R24 Customs Filing Information'— 'EU' field under 'Container and Cargo' section.




• Tick the 'House Master Shipment' checkbox and enter your EORI No. in the 'Declaration EORI (House B/L Declaration)' field.




3.2.3 Filling the cargo description

Fill in the detailed and accurate cargo name in the 'Summary Cargo Description' field, and input an HS Code with at least 6 digits in the 'HS Code' field.



4 Inquiry of Declaration Results

4.1 Login to COSCO Shipping Lines website <u>COSCO SHIPPING Lines</u>. Select 'Documents' on the left side menu, and entry into 'Customs Declaration'.



4.2 Search for declaration result in 'ENS Inquiry'.



4.3 EU Customs feedback

The newly enacted regulations mandate a tiered approach to risk assessment and require timely responses to feedback provided by the EU Customs.

- Assessment complete (AC): Declaration successful, the goods can be loaded on board.
- Request for further Information (RFI): The information is incorrect/missing,
 but the risk is low and the cargo is scheduled for loading; nevertheless, it is imperative to promptly submit the correct and complete information to prevent any impact on customs clearance at the destination port.
- Do Not Load (DNL): There is a significant risk; loading is not permitted.
 The cargo will not be scheduled for loading and it is necessary to update the data promptly and re-filing.
